Этот отчет о смоге получен владельца автомобиля, который более года пользовался магнитным усилителем. Отчет показывает, что двигатель практически не выделяет вредных веществ. Это невероятно для автомобиля 1999 года выпуска с пробегом 100 288 миль (16 1398 км). Обычно автомобили, купленные давно (22 года назад в этом случае) не проходят тест и им запрещают въезд в Калифорнию как серьезным источникам загрязнения.
